and 12' feet at the deep end. Starting blocks are 29.5". The meet host will ensure the

required course requirements.

Keep out of unauthorized areas. Refrain from flash photography during the race starts. No outside chairs are permitted in the facility.

| Meet Rules: | All USA Swimming Inc. and WI LSC rules apply, including safety rules which will be strictly enforced. Wisconsin Swimming warm-up procedures will be in effect. Feet first three*point entries from the starting end of the pool during general warm-ups will be enforced for all sanctioned/approved competition in accordance with the recent change to policy 4.5.2(a). Teams will be assigned warm up lanes to use as they wish. Violators of the Wisconsin Swimming warm up procedure are subject to disqualification. | Seeding: | All events will be Positive Check in, timed finals. Swimmers not checked in prior to the check in deadline will be scratched from that session. For seeding purposes, please submit Short Course Yard times. NT's are acceptable. Special seeding procedures will be used for disability athletes. (USA Rule 202.2.13) |
| | 500 free and 400 IM events will be swum fastest to slowest. Minimum age for Open events is 11 years old. |
| | Events of 200y or longer may be limited. MMSC reserves the right to seed MMSC swimmers in limited events regardless of times. |
| | 1650 Free will be swam fastest to slowest. If timelines allow, we will try to accommodate all swimmers entered in the 1650 free. |
| Conduct: | All clubs will be responsible for their own swimmers. Any swimmer entered into the meet, unaccompanied by a USA Swimming member coach, must be certified by a USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water. It is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement. In accordance with the Federal Video Voyeurism Prevention Act of 2004-the use of camera phones or video recording devices in the locker rooms is prohibited. |
| | Use of audio or visual recording devices, including a cell phone, is not permitted in changing area, restrooms, or locker rooms (USAS 202.4.11H) |
| | Operation of a drone, or any other flying apparatus, is prohibited over the venue (pools, athlete/coach areas, spectator areas and open ceiling locker rooms) any time athletes, coaches, officials, and/or spectators are present. Exceptions may be granted with prior written approval by the Program Operations Vice Chair. |
| | There will be a Lifeguard on duty and medical supervision will be available for the athletes. |
| Deck Changes: | Deck changes are prohibited (USAS 202.4.11I). |

| Entries: | Entries will be accepted by the entry chair starting at 8:00 am Monday, December 11th, 2024. Entries will only be accepted via email. Entries will be accepted until January 12 th , 2024 or until the meet is full, whichever comes first. Teams must submit hard copies, waivers and payment within 72hrs of meet acceptance. |

| Entry Limit: | Swimmers may enter Five (5) individual events per day on Saturday and Sunday. Swimmers will be limited to Two (2) events during the Friday Evening Session. |
| Deck Entries: | DECK ENTRIES will only be accepted for athletes already accepted and competing in this invite. Deck entry fee for individual events is \$10.00. |
| Awards: | Ribbons for 1-10th place in all individual events for 8 and Under, 9-10 and 11-12. Swimmers in the Open category will not receive awards. This meet will not be scored |
| Admissions: | No on-site admission will be charged for spectators. The meet fees include an admission surcharge of \$14.00 per swimmer. This meet will be operated as a "paperless" meet, except for the required meet operations. Heat Sheets will be posted on Meet Mobile, once sign-ins are finalized and meet is seeded. |
