Location: RecPlex Aqua Arena, 9900 Terwall Terrace, Pleasant Prairie WI 53158

Facility: Indoor, 10 lane 25 yard pool with non-turbulent lane lines. Pool depth 7' at the shallow end and 12' feet at the deep end. Starting blocks are 29.5". The meet host will ensure the required course requirements.

Facility rules: Please keep all trash picked up. Please police your area after each session. No glass articles are allowed on deck. Smoking and the use of tobacco is prohibited inside the RecPlex. Keep out of unauthorized areas. Refrain from flash photography during the race starts. No outside chairs are permitted in the facility.

Timing System: A fully automatic Colorado System with manual back-up buttons and back-up watches for each lane..

*Approximate times: warm-ups will begin immediately after the conclusion of the morning session, but not before noon. All events are Positive Check In. Check In will close 20 minutes after the start of warm-ups. Athlete Check-In will be the responsibility of the club coaches. The meet will begin 65 min. after the start of warm-ups.

- Eligibility:** All swimmers must be current members of USA Swimming and in good standing. USA swimming deck registrations will not be accepted. A swimmer's age for the meet will be his/her age as of January 16, 2026.
- Disabled Athletes:** Athletes shall present an [accommodation/modification form](#) to the Meet Director or Meet Referee to assist with any athlete requests.
- Coaches:** Coaches must be current members of USA Swimming to be allowed on deck

Meet Rules:	All USA Swimming Inc. and WI LSC rules apply, including safety rules which will be strictly enforced. Wisconsin Swimming warm-up procedures will be in effect. Feet first three*point entries from the starting end of the pool during general warm-ups will be enforced for all sanctioned/approved competition in accordance with the recent change to policy 4.5.2(a). Teams will be assigned warm up lanes to use as they wish. Violators of the Wisconsin Swimming warm up procedure are subject to disqualification. In granting this sanction it is understood and agreed that USA Swimming and Wisconsin Swimming, Inc. shall be free from any liabilities or claims for damages arising by reason of injuries to anyone during the conduct of the event.
Seeding:	All events will be Positive Check in, timed finals. Swimmers not checked in prior to the check in deadline will be scratched from that session. For seeding purposes, please submit Short Course Yard times. NT's are acceptable. Special seeding procedures will be used for disability athletes. (USA Rule 202.2.13) 500 free and 400 IM events will be swum fastest to slowest. Events of 200y or longer may be limited. MMSC reserves the right to seed MMSC swimmers in limited events regardless of times. 1650 Free will be swam fastest to slowest. If timelines allow, we will try to accommodate all swimmers entered in the 1650 free.
Conduct:	All clubs will be responsible for their own swimmers. Any swimmer entered in the meet must be certified by a USA Swimming member-coach as being proficient in performing a racing start or must start each race from within the water without the use of the backstroke ledge. When unaccompanied by a member-coach, it is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement. Use of audio or visual recording devices, including a cell phone, is not permitted in changing area, restrooms, or locker rooms (USAS 202.4.11H) Operation of a drone, or any other flying apparatus, is prohibited over the venue (pools, athlete/coach areas, spectator areas and open ceiling locker rooms) any time athletes, coaches, officials, and/or spectators are present. Exceptions may be granted with prior written approval by the Program Operations Vice Chair. <i>There will be a Lifeguard on duty and medical supervision will be available for the athletes.</i>
Deck Changes:	Changing into or out of swimsuits other than in locker rooms or other designated areas is not appropriate and is prohibited. <i>Deck changes are prohibited (USAS 202.4.11I).</i>
MAAPP 2.0:	All adults participating in or associated with this meet acknowledge that they are subject to the provisions of the USA Swimming Minor Athlete Abuse Prevention Policy ("MAAPP"), and that they understand that compliance with MAAPP is a condition of participation in the conduct of this competition. Times achieved by an athlete member at a sanctioned/approved meet who is over 18 years of age who had not completed the Athlete Protection Training (or whose APT training had expired) by the date of the swim, will not be able to be uploaded to SWIMS. This includes participation as a member of a relay. These athletes will also be considered "not in good standing" and can be subject to fines under Wisconsin Swimming Policy 11.2.1.

Entries:	Entries will be accepted by the entry chair starting at 8:00 am Monday, December 8th, 2025. Entries will only be accepted via email. Entries will be accepted until January 10th, 2026 or until the meet is full, whichever comes first. Teams must submit hard copies, waivers and payment within 72 hrs of meet acceptance. This is an Open Entry meet, no reservations. All Teams/Clubs are highly encouraged to submit their entries once the entry period is open. No team/club “spots” will be reserved for this event. Entry Fees:	Individual events are \$6.00 each. A Wisconsin Swimming surcharge of \$4.00 per swimmer entered in individual events must be included with your entry. \$8.00 per swimmer facility fee also will apply. Please make checks payable to Mundelein Mustang Swim Club.
Entry Limit:	Swimmers may enter Four (4) individual events per day on Saturday and Sunday. Swimmers will be limited to Two (2) events during the Friday Evening Session.
Deck Entries:	Deck entries will be accepted to fill open lanes. Cost will be \$10.00 per event plus the Swimmers MUST be entered in the meet prior to the event for deck entries to be accepted.
Awards:	Ribbons for 1-10th place in all individual events for 8 and Under, 9-10 and 11-12. Swimmers in the Open category will not receive awards. This meet will not be scored
Events:	Athletes swimming 25 yard events will be starting from the bulkhead end of the course.
Admissions:	No on-site admission will be charged for spectators. The meet fees include an admission surcharge of \$14.00 per swimmer. This meet will be operated as a “paperless” meet, except for the required meet operations. Heat Sheets will be posted on Meet Mobile, once sign-ins are finalized and meet is seeded.
Concessions:	Concessions will be available from the facility. No glass containers are permitted on deck.
Meet Results:	A copy of the results will be provided to each participating team via email and posted on both the MMSC and WI Swimming websites.

Timers:	MMSC will do our best to cover as many lanes as possible. However, some assistance with timing may be needed. If this occurs teams will be notified the Monday before the meet of timing needs. <i>Swimmers competing in the 1650 Free will be responsible for providing their own timer and counter. MMSC will not be responsible for timing or counting these events.</i>
Officials:	There will be a need for officials to help the meet run smoothly. Certified officials should contact Erin Rakickas, Erakickas@hotmail.com. Any assistance that can be provided would greatly be appreciated.
Parking:	There is plenty of free parking available
